About the Oral Health team

The Oral Health team sits within the Integrated and Primary Care Directorate and delivers a full range of dental services and support programs. Our services are provided across three fixed clinic sites (Northcote, Preston and East Reservoir), as well as through mobile and outreach programs including Smile Squad and community-based care. Our team is passionate about advancing oral health for everyone, and we are proud to create a safe, inclusive, and responsive environment that reflects the communities we serve.

Position Purpose

The Dentist plays a critical role in delivering high-quality, client-centred dental care to the communities served by Your Community Health. Working within their full clinical scope and in line with public dental models, the Dentist supports oral health and wellbeing through prevention, treatment, and education.

This role contributes to community outreach and Smile Squad programs in addition to fixed clinic delivery and works collaboratively with a multidisciplinary team to ensure safe, inclusive, and accessible care.

Position Responsibilities

- Provide comprehensive, person-centred dental care including diagnostic, preventive, restorative, and minor oral surgical procedures.
- Operate within full clinical scope in accordance with professional registration, current clinical guidelines, scope of practice, and radiation licence.
- Prescribe and undertake radiography including OPGs (if appropriately licensed), and support clinic radiography operations.
- Integrate digital workflows and Al-supported diagnostics (e.g. CoTreat, 3Shape) into daily clinical decision-making, treatment planning, and quality improvement.
- Deliver care across fixed clinics, mobile vans, schools, aged care facilities, and community venues including Smile Squad and other outreach programs.
- Adapt communication and treatment approaches to meet the needs of children, young people, older adults, and diverse or vulnerable communities.
- Apply trauma-informed and culturally responsive approaches to care delivery.
- Promote preventive and health-enhancing behaviours in both individual and group settings.
- Maintain accurate and timely clinical records using Titanium and other systems, supporting compliance, reporting, and data integrity.

- Liaise effectively with internal team members, the Royal Dental Hospital, schools, aged care providers, and community organisations to ensure coordinated care.
- Participate in clinical discussions, peer review, case conferences, and team-based service planning.
- Engage in audits, clinical governance, quality improvement initiatives, and service evaluation.
- Identify and act on opportunities to improve client safety, service access, and oral health outcomes.
- Support student placements, mentoring, and clinical supervision for graduates and junior staff, contributing to a positive learning culture.
- Engage in ongoing professional development, reflective practice, and maintain AHPRA registration.
- Ensure service delivery meets infection control, privacy, documentation, and regulatory standards.
- Support the achievement of public dental KPIs and program objectives.
- Perform other duties as directed by the Oral Health Manager, Clinical Coordinator, or Senior Dentist.

Position requirements (qualifications, skills, knowledge and attributes)

Qualification, Registrations and Licenses

- Qualification in relevant General Dentistry discipline (essential)
- AHPRA registration as a General Dentist without restriction
- Ionizing Radiation Apparatus Use License in Victoria for Intra-Oral Radiography (Licence to provide dental panoramic radiography is desirable)
- Current Victorian Driver's License
- Ability to speak a community language (desired)

Skills, Knowledge and Experience

- Demonstrated ability to work within full clinical scope safely and effectively
- Strong diagnostic, treatment planning, and radiography skills
- Knowledge of community health principles and public dental care models
- Commitment to culturally safe, trauma-informed, and inclusive care
- Experience working with priority populations, including CALD, ATSI, and special needs groups
- Capacity to work toward service targets and meet program delivery expectations
- Excellent interpersonal and communication skills
- Experience in public/community dental health settings (desired)
- Knowledge of Titanium and other electronic dental records (desired)
- Familiarity with Smile Squad or school/public dental programs (desired)
